1. Terms of Payment

In the table below, select your choice of exhibit area. Tariffs are per week end. Vendors only pay for two days of the festival. Sunday is free of charge. Exhibitions will however remain open until 15h00 on Sunday 8 October 2023.

- 1. No partial payment shall be accepted and no refunds shall be made.
- 2. Upon receipt of your completed and acceptable Application Form, you will be allocated a stand number.
- 3. As soon as a stand number was allocated to you, payment shall be made within 48 hours failing which, your allocated stand will be re-allocated to the next exhibitor.
- 4. Only two persons as indicated in the Application Form shall man the exhibition stall. Any visitors or family shall pay the visitor's entrance fee. A visitors fee of R50 per day or R100 per person for the weekend is payable. Access for children younger than 10 years, is free of charge. Upon presentation of proof of payment, a coloured arm band shall be issued to Vendors and their guests/families.

2. Terms of Application

- 1. Application closes on Friday 20 September 2023
- 2. Only completed and signed Application Forms will be accepted.
- 3. Telephonic and/or WhatsApp bookings will not be acceptable without completed Application Forms.
- 4. Each page of the Application Form shall be signed.
- 5. Your signature confirms that you understand and accept the content of this Application Form and the associated terms and conditions as spelled out herein.
- 6. There will be a FOOD COURT available hence, applications from FOOD STALL operators shall not be considered for 6 and 7 October however, snacks, delicacies, sweets etc. shall be allowed. Applications from FOOD STALL operators may well be considered for Sunday 8 October 2023, in which case, the tariff for one day at Entry Level Small Market fee shall be applicable.
- 7. Preference shall be given to applications from vendors of handcrafted and homemade products that are creative and original.

3. Terms of Use

- 1. Vendors and exhibitors shall ONLY exhibit their goods within the festival terrain.
- 2. Vendors and exhibitors sells and exhibit at their own risk. The organisers, its personnel, the event's management, the Waterfront Park's management, theand/or directors, takes no responsibility of whatever nature for any loss, damage, injury or death. The Vendor/Exhibitor shall indemnify the event organisers through signing a separate Indemnity Form which, is not to be read separate from this Application Form. In the event of failure to sign such separate Indemnity Form, the Vendor/Exhibitor agree, through signature to this Application Form, that it indemnify the event organisers as contained in this Term of Use.
- 3. The Organisers cannot be held liable for bad weather conditions or any losses or damages suffered by the Vendors/Exhibitioners as a result thereof.
- 4. The Vendor / Exhibitor shall provide its own Events Liability Insurance to cover itself from any and all risks related to outdoor events of this nature. The Vendor/Exhibitor confirm that there will be no recourse against the event organiser on any liability claim of whatsoever nature.
- 5. No more than two persons shall overnight in the Waterfront Park at the entry level Small Market Stalls. No fires are to be made on the natural ground i.e. only in purpose designed equipment. Extreme care are to be taken to prevent fires from spreading.
- 6. All "ash" shall be removed regularly, and placed in the provided steel waste drums. Care must be taken not to put hot ash in any drum, which can start a fire.
- 7. The event organisers provide Security that will secure the external perimeter of the festival terrain. Vendors / Exhibitors are responsible for securing their own goods within the festival terrain.
- 8. No pets are allowed on the terrain.

- 9. Being an outdoors event, spreading over a large terrain, the Organisers shall endeavour to provide lighting, water and toilet facilities as conveniently as possible however, the Vendors and Exhibitors are encouraged to be self-sufficient with generators or solar lighting and containers for clean water. Showers and washing facilities will not be available and if the event organizers manage to make such facilities available, it will be primitive and limited.
- 10. The right is reserved to cancel any of the Vendor arrangements if any of the rules or safety requirements are compromised or not adhered to.
- 11. Figures of day visitors to the event, quoted during presentation, are forecasted and made in goodwill and cannot be guaranteed.
- 12. All Vendors shall have their own fire extinguishers in their stall.
